

**ARTICLES OF INCORPORATION OF  
RYDER RANCH COMMUNITY ASSOCIATION**

The undersigned persons, for the purpose of forming a non-profit corporation under the laws of the State of Arizona, hereby adopt Articles of Incorporation as follows:

**ARTICLE I**

**NAME OF CORPORATION**

The name of the corporation shall be RYDER RANCH COMMUNITY ASSOCIATION (hereafter called the "Association").

**ARTICLE II**

**PURPOSE**

The purpose for which the Association is organized is the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Arizona, as they may be amended from time to time, and specifically but not in limitation thereof, the corporation shall be organized and operated as a real estate management association as defined in Section 528 of the Internal Revenue Code of 1954, as amended, to provide for the acquisition, construction, maintenance and care of the Planned Community, consisting of residential Lots and Common Areas within that certain subdivision more particularly described in the Declaration of Covenants, Conditions, Restrictions, Assessments, Charges, Servitudes, Liens, Reservations and Easements for Ryder Ranch, a Planned Community (hereinafter called the "Declaration"), applicable to the property and recorded or to be recorded in the Office of the Maricopa County Recorder, as the same may be amended from time to time as therein provided.

The Association shall exercise all of the powers and privileges and perform all of the duties and obligations of the Association as set forth in the Declaration.

The Association is not organized for pecuniary profit, nor shall it have any power to issue certificates of stock or declare dividends, and no part of its earnings (other than by acquiring, constructing or providing management, maintenance and care of Association property and other than by a rebate of excess membership dues, fees or assessments) shall inure to the benefit of any

member, director or individual; the balance, if any, of all money received by the Association from its operation, after payment in full of the debts and obligations of the Association, shall be used and distributed exclusively for the purposes herein set forth.

The definitions of capitalized terms in these Articles of Incorporation that are not herein defined are defined in the Declaration of Covenants, Conditions, Restrictions, Assessments, Charges, Servitudes, Liens, Reservations and Easements for Ryder Ranch.

### ARTICLE III

#### INITIAL BUSINESS

The Association initially intends to conduct the business of the maintenance and oversight of the Planned Community.

### ARTICLE IV

#### DURATION

The period of the Association shall be perpetual.

### ARTICLE V

### ARTICLE VI

#### MEMBERSHIP AND VOTING RIGHTS

The Association shall be a non-stock corporation and shall be owned by all of its members. The members of the Association and their voting rights shall be as provided in the Declaration and/or the bylaws of the Association.

## ARTICLE VIII

BOARD OF DIRECTORS

The affairs of the Association shall be conducted by a Board of Directors ("Board"). After the end of the Declarant Control Period, as defined in Section 1.22 of the Declaration, the Board shall consist of, and the members shall elect, a Board of at least three (3) directors, as further set forth in the Declaration and/or the bylaws of the Association.

The following three (3) persons shall constitute the Board of the Association until the next annual meeting of the members after the Declarant Control Period ends, or until their successors are duly elected by the undersigned Declarant and qualify as follows:
