19 applicable, in this action in this Court. If served within Arizona, you shall appear and defend
20 within 20 days after the service of the Summons and Complaint upon you, exclusive of the day
21 of service. If served out of the State of Arizona – whether by direct service, by registered or
22 certified mail, or by publication – you shall appear and defend within 30 days after the service
23 of the Summons and Complaint upon you is complete, exclusive of the day of service. Where
24 process is served upon the Arizona Director of Insurance as an insurer’s attorney to receive
25 service of legal process against it in this state, the insurer shall not be required to appear, answer

1 or plead until expiration of 40 days after date of such service upon the Director. Service by
2 registered or certified mail without the State of Arizona is complete 30 days after the date of
3 filing the receipt and affidavit of service with the Court. Service by publication is complete 30
4 days after the date of first publication. Direct service is complete when made. Service upon the
5 Arizona Motor Vehicle Superintendent is complete 30 days after filing the Affidavit of
6 Compliance and return receipt or Officer's Return. RCP 4, A.R.S. §§ 20-222, 28-502, 28-503.

7 YOU ARE HEREBY NOTIFIED that in case of your failure to appear and defend within
8 the time applicable, judgment by default may be rendered against you for the relief demanded in
9 the Complaint.

10 YOU ARE CAUTIONED that in order to appear and defend, you must file an Answer or
11 proper response in writing with the Clerk of this Court, accompanied by the necessary filing fee,
12 within the time required, and you are required to serve a copy of any Answer or response upon
13 the Plaintiffs' attorney. RCP 10(d); A.R.S. §12-311; RCP 5.

14 Requests for reasonable accommodation for persons with disabilities must be made to the
15 division assigned to the case by the party needing accommodation or his/her counsel at least
16 three (3) judicial days in advance of a scheduled proceeding.

17 Requests for an interpreter for persons with limited English proficiency must be made to
18 the division assigned to the case by the party needing the interpreter and/or translator or his/her
19 counsel at least ten (10) judicial days in advance of a scheduled court proceeding.


