17 demanded in the Complaint.

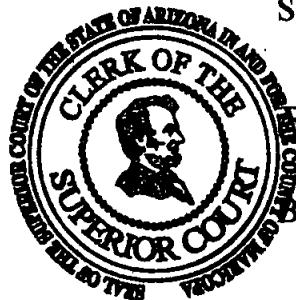
18 YOU ARE CAUTIONED that in order to appear and defend, you must either
