2 applicable, in this action in this Court. If served within Arizona, you shall appear and defend within  
3 20 days after the service of the Summons and Complaint upon you, exclusive of the date of service.  
4 If served out of the State of Arizona - whether by direct service, by registered or certified mail, or by  
5 publication - you shall appear and defend within 30 days after the service of the Summons and  
6 Complaint upon you has been complete, exclusive of the date of service. Where process is served  
7 upon the Arizona Director of Insurance as an insurer's attorney to receive service of legal process  
8 against it in this state, the insurer shall not be required to appear, answer or plead until expiration of  
9 40 days after date of such service upon the Director. Service by registered or certified mail with the  
10 State of Arizona is complete 30 days after the date of filing the receipt and affidavit of service with  
11 the Court. Service by publication is complete 30 days after the date of first publication. Direct  
12 service is complete when made. Service upon the Arizona Motor Vehicle Superintendent is complete  
13 30 days after filing the Affidavit of Compliance and return receipt or Officer's Return. RCP 4; A.R.S.

10 **YOU ARE HEREBY NOTIFIED** that in the case of your failure to appear and defend  
11 within the time applicable, judgment by default may be rendered against you for the relief demanded

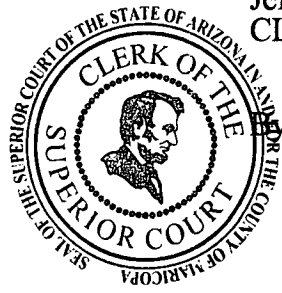
1 Requests for reasonable accommodation for persons with disabilities must be made to the
