I am filing for a motion to quash a subpoena that I was served with on May 15, 2025 to be a witness at an upcoming hearing that is only 7 days from the date the subpoena was served on me! First of all, I am not a party to this case and I have no information that I can provide as a direct witness, I am simply a resident of Sun City Grand ("The Grand") and aside from virtually attending public board meetings held regularly as a community resident, I have no other connection. I have never met the Plaintiff and only barely heard the gossip going around the community.

This subpoena is ordering me to be at the East Court Building on Jefferson Street in Downtown Phoenix on Thursday of this week (May 22, 2025). I live in Sun City Grand(Surprise) and I have no available transportation to get down there and I also have severe medical issues that I can provide documentation for that prevent me from being able to appear in person.

I am diagnosed with Peripheral Arterial Disease (PAD) and the blood flow to my right leg is completely blocked in the main arteries from my groin to my toes and despite numerous procedures over the last year and a half, attempts to unblock have all failed. It severely impacts my mobility and there are days where I can barely get out of my bed to a chair and I have so much pain and swelling that I can't walk even 10 feet.

I also now have arterial blockage in my heart that further impacts my health and I am waiting to be scheduled

for an upcoming heart procedure. I get short of breath and exhausted easily. Finally, I also have severe  
incontinent issues with my bowels due to stress and the medications I take for my heart and leg. These come on  
out of nowhere, and when I am in public I cannot control at all and as soon as it comes on I have severe diarrhea  
that I am unable to hide. As you can imagine, having this in public places is extremely embarrassing and because of  
that I don't go far from my house anymore. On top of that, I dehydrate very easily because of the diarrhea and now  
that we have started the summer heat it is worse for me and I frequently have to stay indoors because of dizzy  
spells associated with the constant dehydration. It was only recently that I was at an event not far from my  
house that I got so dizzy I couldn't walk and other attendees had to call for EMS and an ambulance for me.  
Finally, I am prescribed narcotic pain pills that I have to use frequently and they make me so drowsy I can't function.  
This subpoena that has been issued to me is completely inappropriate based on the fact that again I have no  
information about this case and just the fact that I was ordered to appear out of the blue with only 7 days notice  
has caused me such further stress and anguish right now that it is worsening my heart and leg conditions and  
causing severe undue anguish. There is no way that I can leave my house and attend publicly at the courthouse  
this Thursday so I plead with the court to quash this order and at the most if I still need to answer questions or  
anything else, the only way I am able to physically comply with that is to do it telephonically from my home. I sent  
an email to the Plaintiff's attorney that subpoenaed me on Friday, May 16, 2025 explaining all of this but I have  
had no response so because of that I am now filing this motion to quash this order and if it can't be quashed for any  
reason then I will need to modify to answer questions over the telephone. I am 78 years old and because of all of the  
above medical conditions listed as well as my general health I cannot be downtown at the Court Building this  
Thursday. Thank you for your time and consideration.


