THE COURT FINDS that Mr. Mejia was personally served on May 11, 2016, but failed to file an Answer. He did communicate with Plaintiff's counsel regarding the lawsuit. The Application for the Entry of Default was filed on December 8, 2016. The default became effective. Mr. Mejia filed his Answer May 14, 2017, which was well after the default to become effective.

THE COURT FURTHER FINDS that Mr. Mejia is in default. The Court does not find excusable neglect in his failure to file an Answer. The information presented to the Court was provided through affidavits. Mr. Mejia indicated in his affidavit that he did not understand the mailer due to not speaking the English language. However, the Court finds that he acted and made contact with Plaintiff about the lawsuit and made two offers. This second offer was accepted. However, the Court finds that he did not respond after his offer was accepted. Only after time was give to Defendant to respond did Plaintiff file the Application for Default and still no Answer was timely filed. Mr. Mejia indicated that he had someone in his family that could help him interpret and failed to do so.

THE COURT FURTHER FINDS that Mt. Mejia has not shown excusable neglect and the default shall continue to stay in effect.

As Mr. Mejia is contesting the amount of damages owed,

IT IS ORDERED setting an Evidentiary Hearing regarding the damages on June 20, 2017 at 10:00 a.m. (2 hours allotted), in this Division, 222 E. Javelina Avenue, Courtroom 302, Mesa, AZ 85210.

IT IS FURTHER ORDERED any evidence intended to be submitted as exhibits at the time of the Evidentiary Hearing must be brought to **Courtroom 303 on or before June 13, 2017**. Exhibits are to be separated by a colored sheet of paper or by a divider sheet along with an attached cover sheet listing the description of the exhibits. No duplicate exhibits shall be presented for marking. If either party fails to comply with the steps for marking exhibits, that party's exhibits may be precluded from being marked for the hearing.
