18 Plaintiff Lisa Marx, pro se, moves this Court for an expedited hearing on her Motion for
19 Preliminary Injunction pursuant to Arizona Rule of Civil Procedure 7.1 and good cause
20 shown, due to the imminent October 15, 2025, deadline for the Defendant's invalid
21 amendment consents. This motion is supported by the attached Memorandum of
22 Points and Authorities, my Affidavit, Exhibits A-U, and the record.

23 **MEMORANDUM OF POINTS AND AUTHORITIES**

24 1. **Factual Background and Urgency:** As detailed in my Affidavit and Motion for

1 Preliminary Injunction (filed October 5, 2025), the Board's written consents
2 violate the Condo Act (A.R.S. §§ 33-1227, 33-1248, 33-1250) and evade A.R.S. § 33-
3 1203. The October 15 deadline risks immediate adoption per A.R.S. § 10-3704(E),
4 causing irreparable harm (title clouds, uninsurable risks) before a standard
5 hearing. The board is going door-to-door to get signatures and no response to
6 Plaintiff's September 27 email.

- 7 2. **Legal Basis:** ARCP 7.1 allows expedited consideration for good cause. Imminent
8 harm from the deadline constitutes good cause, as in injunction cases requiring
9 prompt review (ARCP 65(a)). Delay would moot the motion.
- 10 3. **Requested Relief:** Set a hearing within 5 days (by October 14, 2025) to prevent
11 harm.
