

If served out of the State of Arizona -- whether by direct service, by registered or certified mail, or by publication -- you shall appear and defend within 30 days after the service of the Summons and Complaint upon you is complete, exclusive of the day of service. Service by registered or certified mail outside the State of Arizona is complete on the date of receipt by the party being served. Service by publication is complete 30 days after the date of first publication. Direct service is made when complete. Where process is served upon the Director of Insurance, the insurer shall not be required to appear, answer or plead until expiration of 40 days after date of such service upon the Director. In case of your failure to appear and defend within the time applicable, judgment by default may be rendered against you for the relief demanded in the Complaint.
