**MOTION FOR EXTENSION OF  
TIME TO FILE RESPONSE TO  
AMICUS CURIAE BRIEF**

21 Appellant PC Village Association, Inc. (PC Village), through undersigned  
22 counsel, respectfully requests this Court for a 14-day extension of time to file its  
23 Response to the Amicus Curiae Brief of the Arizona Association of Realtors  
24 (AAR). The Response to the Amicus Curiae Brief is presently due December 3,  
25 2012. Appellant requests that the Response to the Amicus Curiae Brief deadline be  
26 extended for 14 days to December 17, 2012. This is Appellant's first request for an  
27 extension to file its Response to the Amicus Curiae Brief.

28 Good cause exists for the requested extension. For some reason, undersigned  
counsel did not receive a copy of the Court's order granting AAR's motion for

1 leave to appear and setting a response deadline until after the Thanksgiving holiday.  
2 Undersigned counsel also has a number of pending deadlines in other cases over the  
3 next several weeks, including a complex Response to a Motion for Summary  
4 Judgment and Statement of Facts due December 11, 2012 in *Fidelity National Title*  
5 *Insurance Company, et al. v. Centerpoint Mechanic Lien Claims, LLC, et al.*,  
6 Maricopa County Superior Court Case No. CV2011-008600; an Opening Brief due  
7 December 12, 2012 in *ML Manager, LLC and Centerpoint Mechanic Lien Claims,*  
8 *et al. v. Fidelity National Title Insurance Company, et al.*, Case No. 1 CA-CV 12-  
9 0726; and an Appellant Memorandum due December 17, 2012 in a lower court  
10 appeal, *State of Arizona v. Cardon*, Case No. 2012027747. Counsel is also in the  
11 process of preparing a complex dispositive motion in *Jeffrey C. Stone, Inc.; Fidelity*  
12 *National Title Insurance Company, et al. v. Osborn III Partners LLC*, Maricopa  
13 County Superior Court Case No. CV2008-033080, as well as a Petition for Special  
14 Action in *Randall v. Maricopa County, et al.*, Maricopa County Superior Court  
15 Case No. CV2011-011867.

16 Appellant avows that this request is made in good faith and not for the  
17 purpose of delay.

18 For the foregoing reasons, Appellant respectfully moves this Court for a 14-  
19 day extension until December 17, 2012 to file its Response to the Amicus Curiae  
20 Brief.
