REQUEST FOR CLARIFICATION

Plaintiff, by and through counsel undersigned, requests clarification from the court with respect to the scope of the April 15, 2016, “Evidentiary Hearing re: monetary penalties and any additional issues” as referenced in this honorable court’s February 26, 2016, minute entry order.

On November 2, 2015, Plaintiff requested that the court consolidate its injunction hearing with a trial on the merits pursuant to A.R.C.P. 65(a)(2). Based on the parties discussions with the Court and the recent minute entries, Plaintiff assumes that the April 15, 2016 Evidentiary Hearing will address both monetary penalties and its request for injunction. Essentially, these are the only two issues before the court. Plaintiff is thus

1 under the impression that the Court has granted its request for a consolidation of injunction
2 and a trial on the merits.

3 For the above reasons, Plaintiff respectfully requests the court confirm whether or
4 not the April 15, 2016 evidentiary hearing on Plaintiff's request for preliminary and
5 perment injunction will be a consolidated with a trial on the merits.
