

Roundtable breakfast meeting consisting of legislators, other elected officials, and business leaders that will go to 10am.

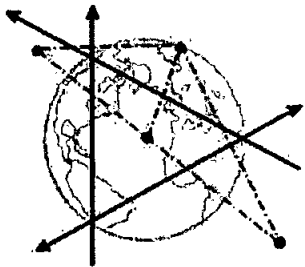
