**THE STATE OF ARIZONA TO DEFENDANT:
PREMIERE VACATION COLLECTION OWNERS ASSOCIATION**

1. A lawsuit has been filed against you. A copy of the lawsuit and other court papers are served on you with this "Summons".
2. If you do not want a judgment or order taken against you without your input, you must file a "Response" in writing with the court, and pay the filing fee. If you do not file a "Response" the other party may be given the relief requested in his/her Petition or Complaint. To file your "Response" take, or send, the "Response" to the Office of the Clerk of the Superior Court, 201 West Jefferson Street, Phoenix, Arizona 85003-2205 or the Office of the Clerk of the Superior Court, 18380 North 40th Street, Phoenix, Arizona 85032 OR Office of the Clerk of Superior Court, 222 East Javelina Drive, Mesa, Arizona 85210-6201 or Office of the Clerk of Superior Court, 14264 West Tierra Buena Lane, Surprise, Arizona, 85374. You are required to mail a copy of your "Response" to the other party's attorney at the address listed on the top of this Summons.

1 3. If this "Summons" and the other court papers were served on you by a registered
2 process server or the Sheriff, within the State of Arizona, your "Response" must be filed
3 within TWENTY (20) CALENDAR DAYS from the date you were served, not counting the
4 day you were served. If this "Summons" and the other papers were served on you by a
5 registered process server or the Sheriff outside the State of Arizona, your Response must be
6 filed within THIRTY (30) CALENDAR DAYS from the date you were served, not counting
7 the day you were served. Service by a registered process server or the Sheriff is complete
8 when made. Service by Publication is complete thirty (30) days after the date of the first
9 publication.

10 4. You can get a copy of the court papers filed in this case from the Plaintiff's Attorney
11 at the address listed below, or from the Clerk of the Superior Court's Customer Service
12 Center at 601 West Jackson, Phoenix, Arizona 85003, or at 222 East Javelina Drive, Mesa,
13 Arizona 85210.

20 5. If this is an action for dissolution (divorce), legal separation or annulment, either or
21 both spouses may file a Petition for Conciliation for the purpose of determining whether
22 there is any mutual interest in preserving the marriage or for Mediation to attempt to settle
23 disputes concerning custody and parenting time issues regarding minor children.

24 6. Requests for reasonable accommodation for persons with disabilities must be made
25 to the office of the judge or commissioner assigned to the case, at least ten (10) days before
26 your scheduled court date.
